- Visa Application fee: £479
- Immigration Health Surcharge fee:
 £776/year
- Living Costs fee: £1023/month for 9 months (£1,334/month for London)
- Flight tickets from your country to the UK

 - Maximum of **20 hours**/week
 - Minimum wage: **£11.44**/hour

International Postgraduate Scholarships

BU Academic Excellence Scholarship*

£3,750

When you achieve the equivalent of a UK Hons degree with **2:1** or above (and equivalents)

No need to apply. Sept 2024 and Jan 2025 entry.

*All taught full-time Postgraduate Taught courses are eligible, except for any distance learning courses.

*Scholarships cannot be deferred.

| Chevening Partner Scholarship scheme | Full-time applicants for MSc Adult Nursing, MSc Marketing Management, MA 3D Computer Animation and MSc Digital Health who are a citizen of Turkey , Thailand, Taiwan, Indonesia, Hong Kong or China and who intend to return there at the end of study. | A tuition fee waiver plus other allowances | Apply online - the deadlines are country-specific but the application window is usually between August and November each year for September entry in the following year |
| Bournemouth University - GREAT Scholarships 2024 | Applicants for full-time taught postgraduate courses who are resident in Indonesia or Thailand . You must have achieved a minimum of a UK upper second-class Honours (2:1) degree (or overseas equivalent) that is relevant to your postgraduate study | £10,000 tuition fee reduction | Apply online by 30 April 2024 |
| Commonwealth Scholarships | Full-time applicants for a postgraduate taught course. All awards are made strictly based on academic meri t and their potential to contribute to the needs of their home countries. | A tuition fee waiver plus other allowances. | Over 800 scholarships each year to applicants from Commonwealth countries. |
